



ACKNOWLEDGEMENT OF RULES AND REGULATIONS

RE: FAMILIARIZATION WITH FIREARMS

1. This acknowledgment points out that the City of Albany has not offered legal advice in any manner. All participants in this event are encouraged to consult an attorney of their choosing.
2. Undersigned is fully aware that handling a firearm, shooting and all associated activities are inherently dangerous and can lead to injury or death and no amount of care, caution, instruction, or expertise can eliminate these risks.
3. Undersigned understands that there is no charge for this event; that it is being held on property owned by the City of Albany and used for recreational purposes; as a consequence the City of Albany is immune from litigation pursuant to O.C.G.A § 51-3-20, et seq.
4. All firearms brought to the event must be cleared and empty of ammunition.
5. All participants must bring safety glasses and hearing protection. Absent same, one may not participate in this event.

Undersigned hereby acknowledges and agrees that he/she has read this instrument and understands its terms and is executing this instrument voluntarily. Undersigned further certifies that he/she is eighteen (18) years of age or older and states that he/she is not under the influence of alcohol, drugs, and/ or other mind-altering substances. Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all range rules and procedures and any other rules and procedures outlined at the event. Failure to follow range rules will result in expulsion from this event.
