AN ORDINANCE AMENDING THE ZONING ORDINANCE AND MAP OF THE CITY OF ALBANY (ORDINANCE NO. 09-102) SO AS TO CHANGE THE STATUS OF THE PROPERTY HEREINAFTER DESCRIBED

BE IT ORDAINED by the Board of City Commissioners of the City of Albany, Georgia, and it is hereby ordained by the authority of same:

<u>SECTION I:</u> That from and after the passage of this Ordinance the official Zoning Ordinance and Map of the City of Albany, Ordinance No. 09-102, adopted January 27, 2009, as amended, and the same hereby is further amended so as to change the status of the property hereinafter described as follows:

TO: C-3 (Commercial District)

LOCATION : 1920 Ledo Road (Wilmar Lane Portion)

OWNER/APPLICANT : Drake Properties of SWGA/Sherri Smith

ZONING CASE : #23-005

All that certain tract or parcel of land situate lying and being part of Land Lot 408 of the First Land District, Albany, Dougherty County, Georgia and being more particularly described as follows: Begin at the northeast corner of Lot 14 of Hidden Court Subdivision as recorded in Plat Book 1D, Page 9H of the public land records of Dougherty County. degrees 03 minutes 56 seconds West for a distance of 929.44 feet to the Point of Beginning. Said tract or parcel contains 12.802 acres.
