David Hamilton, Transportation Director, discussed information (copy on file) regarding the request to purchase terminal furniture.

Paul Forgey, Planning Director, and Robert Griffin, Interim Engineering Director, were present to discuss the following (copy on file)

3. Grant request to the GA Dept of Natural Resources re: Recreational Trail Grant Program

Using a power point presentation (copy on file), Mr. Forgey showed photos of various Third Avenue improvements, which include a trailhead, bike routes/benches, a pocket park, access improvements with the minimum option being the Trailhead (\$211,962) and 3rd Ave., access (\$533,404). He advised that the grant amount is \$200,000 with a total of \$750,000 for this option, with the City's match of \$550,000, adding that the pocket park, the City's match will be increased to \$714,000. He explained that incorporating all options takes the entire project to \$1.37 million.

Mayor Pro Tem Warbington suggested the top two options (trailhead and 3rd Ave access) are best at this time. Commissioner Langstaff said he uses the trail and feels the money can be better spent regarding connectivity to Chehaw from Cox Landing and asked the status of this project. Mr. Carter stated that the Chehaw connection is not a project at this time; however, it can be brought back. Discussion continued regarding various plans, including a pedestrian bridge with the dollar amount escalating and is the reason to ask the state for funding the Chehaw option.

Commissioner Young agreed with Commissioner Langstaff's proposal, with Mr. Forgey and Mr. Carter stating that the deadline prevents including the Chehaw proposal. Discussion continued regarding options.

Mayor Pro Tem Warbington moved to adopt the following resolution using only Option 1 and II, seconded by Commissioner Johnson, and following a roll call vote, the motion unanimously carried.
