Mayor Dorough stated that he has discussed with CFO and Mr. Carter agreed that Derrick Brown will be the interim. Discussion included his salary, with Mayor Dorough noting that Mr. Brown's

calculation indicates that an additional \$2300/month is his recommendation, adding that this would be his recommendation as well.

Commissioner Johnson moved to approve, seconded by Commissioner Howard, the roll call vote unanimously carried.

At the request of Commissioner Howard, Mr. Brown provided a brief history of his employment with the City of Albany and stated that he started working with the city in 2010 and has worked with two former City Managers. He mentioned having experts in the Finance Department, which he will rely on and said Commission priorities will be moved forward. He thanked the seven elected officials for the unanimous vote and said he looks forward to working with staff.

CITY MANAGER SEARCH PROPOSALS

Towanna Howard, HR Director, requested to move forward with the search to include the three companies that submitted proposals. She gave a brief overview of the process that all companies will use and recommended Underwood and Company.

Commissioner Johnson stated that he supports Underwood.

Commissioner Warbington asked if GOV HR was used when the search was in place for Mr. Carter and referenced the issues that surfaced. Ms. Howard stated that she was not involved in that process.

In reply to Commissioner Young regarding higher costs for the other two, Ms. Howard stated that some included cost of travel, social media presence, etc., hidden costs (background checks, drug screenings, etc.), adding that all companies use the same social media outlets.

Mr. Carter reminded the Commission that Mr. Berry (Underwood Co.) knows Albany and will make a recommendation due to his knowledge of the layout, adding that the same type of search will be conducted with a vested interest in Albany. Commissioner Young mentioned having a deeper pool and a well-rounded selection of candidates.

Commissioner Johnson moved to hire Underwood & Co., seconded by Commissioner Warbington, the roll call vote carried 5-2 with Commissioners Howard and Young voting no.

At 9:54 am Commissioner Warbington moved to enter executive session to discuss property acquisition and pending litigation, seconded by Commissioner Johnson; the roll call vote unanimously carried as follows:
