# REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE CITY OF ALBANY, GEORGIA GOVT. CENTER – RM 100

Mayor Hubbard called the meeting to order at 10:32 A.M. (Commissioners Howard and Postell did not enter the meeting until 10:35).

The Pledge of Allegiance followed a moment of silence.

Commissioner Coleman moved to approve the minutes of the previous meeting, seconded by Commissioner Marietta; the motion unanimously carried.

## REPORT OF COMMITTEE OF THE WHOLE

Commissioner Marietta moved to approve the following Alcohol License Application – Transfer of Ownership, seconded by Commissioner Coleman; the motion unanimously carried.

#### **ORDINANCE**

Commissioner Langstaff introduced

### AN ORDINANCE NO. 17-100

Amending Article VI of Chapter 2 of the City Code adding Sec. 2-265 providing that the City Manager may enter into contracts as well as approve invoices during State of Emergency; Setting limitations

Commissioner Langstaff then offered the ordinance and asked for unanimous consent to dispense with the second reading and asked for its adoption, seconded by Commissioner Postell.

Discussion followed with Commissioner Langstaff asking for clarification on the amount. Mr. Davis stated that the three requirements, as noted in the sections of the Ordinance would have to be met in order for the expense to fall within the ordinance as adopted. Commissioner Howard asked about the state of emergency enacted by the Governor and its expiration. Ms. Subadan said it was extended by 14 days, etc. In reply to Commissioner Postell, Mr. Davis explained that the items to be paid had to fall within the category of the three requirements as noted. Commissioner Coleman questioned whether the ordinance is retroactive to the beginning of the storm with Mr. Davis stating that the ordinance is effective today, adding that if the expense to be paid meets the requirements and predates the ordinance, it can be paid. Commissioner Howard asked Ms. Subadan if Governor Deal can be asked today to extend the state of emergency. Ms. Subadan said she will pass the information on to appropriate individual(s).

Hearing no further comments, the motion unanimously carried.
