1. Zoning Case #16-002 – SOWEGA Warehousing, LLC/Owner; Todd Davis/Applicant; request to rezone property located at 1908 N. Slappey Blvd. from C-2 to C-3.

Using a power point presentation (copy on file) Paul Forgey, Planning Director, discussed the application and displayed an aerial map of the location, adding that the request to rezone will allow for off-site storage. He briefly discussed surrounding zoning, the zoning history, the land use map, future land use map and planning consideration, advising that the Planning Commission recommends approval.
