She briefly discussed the 120-day extension, which was granted in May. Consensus was reached between the City and County to enter into mediation should an agreement not be achieved; the first mediation was conducted with progress being made; however, there was no resolution. Therefore, it was decided that another 120-day extension is the best course of action; it expires February, 2017. She said that she and Mayor Hubbard were involved in the mediation and progress has been made. Commissioner Postell asked that she and Mayor Hubbard provide updates on the matter.
