Mayor Hubbard called the meeting to order at 6:42 p.m.

The invocation was given by Associate Minister Sydney Curley, Second Mt. Zion Baptist Church, followed by the Pledge of Allegiance.

Commissioner Postell moved to approve the minutes of the previous meeting, seconded by Commissioner Howard; the motion unanimously carried.

PUBLIC HEARINGS

1. Zoning Case #15-047 – Chip Leveson & Tim Coley, Owners/Applicants; request to rezone property located at 605 Lockett Station Road from C-7 to R-2

Using a power point presentation (copy on file) Mary Teter, Planner discussed the application and maps of the area. She explained that the request to rezone will allow development of single family dwellings without the commercial requirement. After a review of the zoning history and planning considerations, she advised that the planning commission recommends approval.

Discussion followed with Commissioner Postell expressing concerns regarding use of cesspools/ septic tanks and not being on city sewer. Ms. Teter explained that the guidelines were met, with Commissioner Postell requesting to see information regarding EPA's regulations/requirements.

Commissioner Marietta stated that owners in that area cannot hookup to City services, and suggested that they would be happy to be on the City's sewer system.

Commissioner Langstaff said he just looked up cesspools vs. septic tanks and agreed with Commissioner Postell that there is a federal ban on cesspools, which are different from septic tanks.

In reply to Commissioner Howard regarding the Brookhollow area, Ms. Teter stated that the property is not in the flood plain. Commissioner Marietta mentioned that the Brookhollow area was abandoned years ago and suggested this being a good project for the area.

There was no one signed up to speak for or against this matter.

2. Special Approval #15-049 – New True Fellowship Missionary Baptist Church, Owner/Applicant, request special approval to allow for expansion of an existing religious institution to property located at 1113 Gillespie Ave

Using a power point presentation (copy on file), Ms. Teter discussed the application and maps and advised that the request is to expand the church. After a review of planning considerations she advised that the Planning Commission recommends approval.

In reply to Commissioner Postell, Ms. Teter discussed parking and stated that the building in question is owned by Winfred Dukes, who approved the request.

Commissioner Marietta stated that he inspected the area and commended the church for cleaning up the area. Commissioner Fletcher said she spoke with Winfred Dukes, who is in favor of the request.

Hosea Miller, Pastor of the church, spoke in favor of the application and thanked Commissioners for their support.
