# RECOGNITION OF ALBANY POLICE DEPARTMENT – OFFICER OF THE YEAR, CIVILIAN OF THE YEAR AND CITIZEN OF THE YEAR

Chief John Proctor and Mayor Hubbard presented awards to the following: Pastor Gabriel Martin – Citizen of the Year. Mayor Hubbard thanked Pastor Martin and commended the work she does on behalf of the city, adding that the Police Department cannot do it all alone; it takes citizens, like her, to help move the community forward. Sonya Johnson and David Sparks were named Civilians of the Year. Mayor Hubbard thanked both for their efforts in assisting Albany Police Department in obtaining the CALEA designation, especially in receiving the accreditation in 18 months rather than the 36 it normally takes. Kawaski Barnes was recognized as APD Officer of the Year. Mayor Hubbard thanked Officer Barnes and his wife for their teamwork, which greatly benefit the citizens of Albany.

#### A RESOLUTION NO. 14-R108

Authorizing the City Manager or his Designee to enter into a Contract with Niles Bolton Associates re: Multimodal Transfer Center

Commissioner Langstaff asked how much money is left for the multimodal. Wes Smith, Assistant City Manager, stated approximately \$4.0 million, adding that GDOT offered to assist in potential future applications for additional monies.

Discussion followed with Commissioner Postell asking for clarification regarding the funding. Mr. Smith explained that GDOT met with staff and pledged to find additional money to assist with construction. Commissioner Postell questioned funds for the environmental assessment, with Mr. Smith explaining the cost of the assessment, the \$4.0 million and GDOT funding. Mr. Taylor clarified that the money will not be used for the assessment, but will assist with other funding. In reply to Commissioner Postell, Mr. Smith stated that the environmental assessment will cost \$211,000 and that half will come from this year's budget with the other half coming from FY 2015; the study will begin immediately. Commissioner Postell questioned the date of

completion of the study and if it will be completed in July 2015. Mr. Smith advised that it could take up to one year, but staff is working to reduce the time. He explained the expense change in regulatory requirements, etc. Commissioner Postell questioned money to build the center when the study is complete. Mr. Smith stated that construction would not be ready before the fall of 2014, adding that staff will do an RFP for design services for construction. Commissioner Postell questioned the cost to move the project forward. Mr. Smith stated that the study determines the best layout and determines cost, timeframe, etc. Mr. explained that they do not know the total cost, adding that the cost for land acquisition is unknown at this time. He mentioned that depending on the design, this will also have an effect on the cost, but the design options will be brought to the Commission to review. In reply to Commissioner Postell, Mr. Taylor reiterated that the cost of land acquisition is unknown at this time and any environmental issues that may be found must be resolved.

Hearing no further comments, the motion unanimously carried.

#### **CONSENT AGENDA**

Mayor Pro Tem Howard moved to approve the following consent agenda, seconded by Commissioner Marietta; the motion unanimously carried. Commissioner Postell stated that he wants the record to show that two of the police interceptors will go to the Gang Task Force.
