#### **PUBLIC HEARINGS**

1. Zoning Case #18-016 – Byron B. Rhodes, Jr./Owner; SOWEGA Chlorinator Co., Inc./Applicant; request to rezone property located at 1601 N. Monroe St. from R-3 to C-3

Using a power point presentation, Planning Director Paul Forgery reviewed the application, which included location of the property; surrounding zoning; previous rezoning; current zoning allowing reasonable economic use; approval of application allowing a commercial parking lot for company vehicles of the adjoining existing business (SOWEGA Chlorinator Co., Inc.), adding that currently those vehicles are parked on the street; aerial view; trip generator, which was based on the warehouse since parking lots do not generate traffic by itself; and Future Land Use Map. He advised that the Planning Commission unanimously recommend approval to rezone to C-3.

There was no one signed up to speak in support of or against the application and there were no questions/comments on this item.

2. Zoning Case #18-017 – W.W. Grainger, Inc./Owner; Performance Leasing Co., LLC/Applicant; request to rezone property located at 1710 E. Oglethorpe Blvd. from C-2 to C-3

Mr. Forgey reviewed the application using power point presentation, which included location of the property; approval of the application allowing a truck sales dealership, which is not allowed in a C-2 District; previous rezoning; surrounding zoning; rezoning being suitable with adjacent commercial operations located on E. Oglethorpe Boulevard corridor, with no adverse effects on the commercial properties; surrounding Land Uses; aerial view; and Future Land Use Map. He advised that the Planning Commission unanimously recommends approval to rezone to C-3.

In response to Mayor Hubbard, Mr. Forgey advised that they will be selling commercial, semi-trucks.
