WHEREAS, it is necessary to make an adjustment to the FY 2020 Budget so as to accurately reflect FY 2020 expenditures for the Brownfield Revolving Loan Grant Fund of \$192,000, all as described in that certain agenda item dated September 4, 2020, prepared by Procurement; and

Statement of Issue:

- Amending the City of Albany's Fiscal Year 2020 Budget

History/Facts and Issues:

In order to implement the RLF, the City must hire a Qualified Environmental Professional (QEP) to assist with the technical aspects of the program. Cardno has provided satisfactory assistance with the current Brownfield Assessment grant and has significant experience with the RLF program.

The contract with Cardno of Norcross, GA will be on a time and materials basis to provide technical support to the City to implement the Brownfield Revolving Loan Fund.

Recommended Action:

Contract with Cardno for an estimated expenditure of \$192,000.00. If approved, a corresponding budget amendment will be required for the Grant Fund.
